India's Plethico Pharmaceuticals to acquire Natrol of US for 80.7 mln usd

MUMBAI (Thomson Financial) - India's Plethico Pharmaceuticals Ltd said it has agreed to acquire US-based nutritional products maker **Natrol Inc** for 80.7 mln usd.

In a filing to the Bombay Stock Exchange, Plethico said the acquisition will be effected by an initial general tender offer by its subsidiary for all outstanding shares of Natrol (nasdaq: **NTOL** - news - people) at 4.40 usd per share in cash.

This will be followed by a second-step cash-out merger in which all remaining untendered Natrol shares will be acquired at the same net cash price per share, it added.

Plethico said the acquisition will help the company expand its international presence in key markets like Commonwealth of Independent States, Africa, South East Asia and Latin America.

At 5.50 GMT, Plethico shares were up 6.64 pct at 497 rupees, while the overall market was up 0.20 pct at 19,736.87 points.
